Customers with active support contracts for 7500R Series products will continue to receive support from Arista TAC (Technical Assistance Center) according to the dates listed in Table 2, the End-of-Life Milestones, as long as the systems remain covered under a support contract.

Migration Options

Customers affected by the End of Sales are encouraged to plan a migration to models that provide equivalent functionality or higher performance. The Arista DCS-7500R3-36CQ-LC, DCS-7500R3K-36CQ-LC and DCS-7500R3K-48Y4D-LC should be considered as alternatives depending on the nature of the networking requirements.
